Availability Update for Cytarabine Injection: Multiple Presentations

Dear Customer,

Pfizer Hospital is committed to providing timely supply information so that you can plan for patient care. As such, we want to notify you that we are anticipating a temporary limited supply situation for several of our Cytarabine Injection presentations arising from increased demand due to competitor shortages.

While Pfizer has increased production in an effort to sustain supply during this period and will continue to do so until the market shortage is resolved, inventory is expected to remain limited for several weeks. Pfizer estimates full recovery—when we have sufficient inventory available to meet historical demand projections in addition to several weeks of safety stock in our distribution centers—by Q1 2022.

The table below denotes the supply status of each of Pfizer Hospital's Cytarabine Injection presentations. While several presentations remain available in full or limited supply with upcoming deliveries, supply of Cytarabine Injection 2 g/20 mL (100 mg/mL) Single Dose ONCO-TAIN™ Glass Fliptop Vial, in particular, is constrained. To help ensure equitable distribution of this specific presentation, Pfizer will limit access to Cytarabine Injection 2 g/20 mL (100 mg/mL) Single Dose ONCO-TAIN™ Glass Fliptop Vial to customers with emergency needs only, available via direct shipment. As additional deliveries are received, we will release some product through wholesale partners, so please continue to check your wholesalers first, prior to submission of a direct emergency order request. Please contact your Pfizer sales representative with your emergency request to ensure your needs are met.
