Product NDC Change

Dear Valued Customer,

Pfizer Hospital is pleased to share the NDC change for **Ketorolac Tromethamine Injection, USP 60 mg/2 mL (30 mg/mL) Single Dose Glass Fliptop Vial** is now available at wholesalers and distributors (please note locational inventory may vary).

While there is a difference in NDC and label, as detailed in the Product Information table below, please note there is no change to unit of use price, unit of sale size, or indications. Please keep in mind that as we transition to the new NDC, 00409-3796-25, both labels may be in the marketplace temporarily.

340B INVENTORY REPLENISHMENT

Pfizer recognizes that a product transitioning to a new NDC number can impact product inventory accumulations for 340B covered entities. The Product Table below outlines both the existing and new NDCs. Because the new NDC is for the same product (drug, dosage form, and package size), and has the same 340B price as the corresponding existing NDC, eligible 340B covered entities may use a 340B compliant inventory replenishment model to transfer accumulations of the old NDC toward replenishment of equal quantities of the corresponding new NDC.



